## Guidelines

The IAA is pleased to offer continuing educational scholarships to **current IAA members** in good standing who have paid membership dues and have been paid members of IAA for over one calendar year and conducts a majority of their practice in Indiana.

- Funds may be used to attend local, state, or national conferences.
- Preference is given to members who have not previously received an educational scholarship from IAA.
- A member can receive funds only once per calendar year.

Please allow the IAA Award Committee up to 10 days to review and respond to your request.

Details:

- Those awarded a scholarship will be notified by the Award Committee Chair.
- The scholarship recipient will pay all expenses and reimbursement will be available after expense review by the committee.
- Up to \$500.00 of expenses may be covered. No financial match is required. Allowable expenses are conference registration (no side trips or special conference package trips), lodging, and round-trip transportation (airfare or mileage at the current IRS rates, and shuttle from airport to conference center. Meals and car rental are not included.
- After attending the event, the awardee is required to send (*within 10 days after the event*) all original receipts to the [IAA address listed above](#):
  - Lodging, travel, and shuttle receipts indicating date and place (no receipt, no reimbursement)
  - An agenda of the conference with registration paid receipt and the attended sessions highlighted.
  - Recipients are expected to share pertinent ideas gleaned from the conference that may be of interest to the IAA membership. This may be done via a written summary to the IAA Board of Directors or an article for the *Hoosier Arborist*.
